Wildlands - Only 4% of Oregon is permanently protected as Wilderness, the highest level of protection that Congress can bestow on federal lands. We lag behind our neighbors (WA-10% and CA-15%) in safeguarding these natural treasures and Oregon Wild works to fix our Wilderness deficit. In the past year, we helped to push forward proposals to protect the old-growth forests and mysterious waterfalls of the Devil's Staircase Wilderness (passed out of the U.S. Senate) and the rushing whitewater and ancient forests of the Wild Rogue Wilderness (passed out of Senate committee). Meanwhile, we continued to build the foundation for a large, signature campaign to protect over 500,000 acres in the Crater Lake Wilderness proposal.
As we worked to proactively protect landscapes, we also fought to safeguard public forestlands at risk - specifically western Oregon's BLM O&C lands, a vital checkerboard of forests stretching from Portland to Medford and providing clean drinking water for over 1.5 million Oregonians. These forests are essential for endangered wildlife and vital in our efforts to combat climate change and Oregon Wild has worked over the last year to educate the public, campaign in the media, and convince decision makers to keep these forests standing.

4b (Code:) (Expenses \$ 75,896 including grants of \$ 17,000) (Revenue \$ 600)
Wildlife - In our efforts to protect native species, Oregon Wild safeguards critical habitat and works to ensure federal and state agencies manage at-risk wildlife to put them on a path to recovery. In the past year, Oregon Wild worked to craft a landmark settlement agreement with the State of Oregon halting illegal wolf killing and giving the state the most progressive wolf conservation plan in the nation. While working to protect wolves in the state legislature and in the courts, we also helped Oregonians experience wolf country by leading our 4th annual Wolf Rendezvous trip to northeast Oregon.
In addition to wolf recovery, we focused our efforts in the last year on building support for other keystone species just starting to recover in Oregon - including sea otters, wolverine, and condors. These native wildlife will need advocates as their numbers grow and Oregon Wild will work to educate Oregonians about the role these amazing wildlife play in the ecosystem and strive to create a regulatory environment that leads to their full recovery.

Waters - Our waters are a critical resource. We work to ensure our water sources remain pure and able to sustain human and wildlife populations. In the past year we worked with a coalition of conservationists to pass Senate Bill 838 in the Oregon legislature. This bill curtails the harmful practice of suction dredge mining in Oregon rivers by limiting available permits to 2008 levels while requiring new regulations to protect wild salmon. Also in the legislature, we completed a decades-long campaign to protect the purity and solitude at Waldo Lake (one of the purest lakes in the world) by banning gas motor use.
Out long standing work in the Klamath Basin was as important as ever this year as we drew national attention to the plight of the Klamath National Wildlife refuges during the punishing summer drought. We continue to be the leading organization working to restore balance to this essential ecosystem at the heart of the Pacific Flyway by bringing water demand back into line with what nature can provide and fighting to end leaseland agriculture on the refuges.
